PROJECT MANAGER, RAPTOR POPULATION INDEX PROGRAM. Hawk Migration Association of North America (HMANA) is seeking a project manager for its component of the Raptor Population Index (RPI) program. RPI is a joint effort of HMANA, HawkWatch International and Hawk Mountain Sanctuary to use counts of migrants to assess population trends and conservation status of North America's migratory raptors. Initial funding is from a 1-year renewable challenge grant from the National Fish and Wildlife Foundation and matching contributions from the RPI partners and friends. HMANA, formed in 1975, is a volunteer organization that currently has no full-time paid staff. The project manager will be responsible for all aspects of HMANA's contribution to the RPI program, including acquisition and flow of current and historical counts into the database, liaison with watch sites and partners, writing reports and popular articles, meeting HMANA's commitments to its partners and to granting agencies, budget management, program planning and development, fund-raising both for current income and long-term sustainability, and public relations.

Qualifications should include management of volunteer-based ornithological surveys, understanding basic concepts and data needs of migration monitoring, demonstrated record of oral and written communication including technical writing and fund-raising, ability to design and produce reports, brochures, fund-raising materials, web pages, etc., experience managing projects and budgets. Prior knowledge of raptor migration and the hawk-watching community is desirable but not essential. Salary range \$35,000-\$45,000 per year, commensurate with experience. Location: negotiable. The position is expected to be full-time, dependent on funding; part-time (3-5 days per week, negotiable).
